



PLAN Council Alberta Private Membership Agreement

We are Men and Women of PLAN Council Alberta, do declare our Private Membership Agreement (PMA) to exercise our right of “freedom of association” and “right of self-determination” as given directly from our Creator through Natural Law.

PLAN Council Alberta PMA is restricted to the private domain and is outside of the jurisdiction of government entities, agencies, officers, agents, contractors, and other representatives as provided by the public domain.

Mission:

In accordance with Natural Law, PLAN Council Alberta PMA

- provides and shares knowledge and information, including practical application of life skills, experience, written documentation and facts, to all those who seek truth;
- creates a new model for conducting and structuring our interactions and manifesting our existence through a lifelong interaction of spiritual ideals, community and nature; and
- provides a lifetime medium through which its individual members may associate for actuating and bringing to fruition the Mission as declared.

Declaration of Principles

We declare and recognize these guiding principles are the foundation upon which the Mission of our Membership Agreement shall be accomplished:

First Principle

Natural Law grants unalienable rights to all living men, women and children as bestowed by nature, God or Divine Creator. These rights cannot be denied or restricted by any government or individual.

Second Principle

All Men/Women are created equal and are endowed with a universal spirit that is life itself.

Third Principle

Do unto others as you would have them do unto yourself; Do no harm; Do not steal; exist together free of debt and slavery.

Fourth Principle

All Men/Women have a responsibility to be good stewards of land, air and water through balancing the development of the necessities of life with the well-being of earth’s natural resources.

Fifth Principle

Sovereignty inherently requires Men/Women to acknowledge, accept and practice self-responsibility, integrity, respect and trust.



Sixth Principle

All Men/Women have the inherent right of self-governance, guided by their own moral authority. Hierarchies, royalty or preordained governing individuals are not recognized.

Seventh Principle

Man/Woman will not engage in immoral behaviours including murder, assault, rape, theft, trespass, lying and coercion. No Man/Woman may steal from another.

PLAN Council Alberta PMA establishes a free and independent membership, whereby every member collectively and individually does affirm and make this declaration their own.

Each Man/Woman who joins PLAN Council Alberta PMA hereby agrees to the Guiding Principles of this collective agreement and pledges to uphold those principles.

Membership to the PLAN Council Alberta PMA can be terminated if there is proven serious breach of principles or causing harm to a member. Notice of termination is carried out by a trustee at any time, should they conclude that a specific member is interacting with them or any other members in a way that is contrary or detrimental to the focus, principles and betterment of the PMA.

A member's rights of complaints or grievances must first be handled directly between members involved. If not resolved, it will be mediated within the PLAN Council PMA, or tribunal drawn from within the membership.

A Member may rescind their membership in the PLAN Council Alberta PMA at any time.



Member Declaration

I enter into this agreement of my own free will without any pressure or coercion. I affirm that I do not represent any Public, Local, Provincial or Federal agency whose purpose is to regulate and approve products or services, or to carry out any mission of enforcement, entrapment or investigation.

I agree to contribute to the fulfillment of the Mission of PLAN Council Alberta PMA, and to uphold the Guiding Principles upon which it is founded.

I am voluntarily changing my capacity from that of a public person to that of a private living Man/Woman when participating at any time within the PLAN Council Alberta PMA.

My activities within PLAN Council Alberta PMA are a private contractual matter that I refuse to share with the Local, Provincial/Territorial, or Federal investigative or enforcement agencies.

I agree not to pursue any course of legal action against a fellow member of PLAN Council Alberta PMA, unless that member has exposed me to a clear and present danger of substantive evil, and upon the recommendation and approval of PLAN Council Alberta PMA.

I have read and fully comprehend this agreement, and my questions have been answered fully to my satisfaction. I know that I can withdraw from this agreement and terminate my membership in this association at any time, and that my membership can and will be revoked if I engage in abusive, violent, menacing, destructive or harassing behavior towards any other member of PLAN Council Alberta PMA.
